CAJUN INDUSTRIES, LLC MODULE ASSEMBLY YARD COMING TO PORT OF IBERIA

Cajun Industries based in Baton Rouge, will develop a world-class module assembly yard at the Port of Iberia. The facility will feature 61 acres, with 33 acres developed during the first phase. Developments include stabilization effects achieving a ground gearing pressure of 2,500 PSF and critical infrastructure improvements to support 600 craft.





The Port of Iberia having direct access to the Gulf of Mexico via the Acadiana Gulf of Mexico Access Channel (AGMAC) was instrumental in Cajun's site selection. Not only will Cajun be able to accommodate modules shipped via water, but they will be able to ship large, truck-able modules as well via US Hwy. 90. Craig Romero, Port of Iberia Executive Director, stated the Cajun's facility will be a boost to the Acadiana economy. "Cajun expects to employ more than 600 skilled workers, including crane operators, ironworkers, pipefitters, and welders. We're very excited about having them at the Port of Iberia."

AGMAC DREDGING AND MILLENNIUM EXPANSION PHASE III UPDATE

Acadiana Gulf of Mexico Access Channel Phase II is nearing completion of dredging 20 miles from Intracoastal City to the Freshwater Bayou lock. This will complete the 60 miles of dredging which began over 3 years ago with a total project spend of \$126 million.

Craig Romero stated he is already seeing the benefits of this project with new companies interested in the Port of Iberia. Romero also stated he is in negotiations with a very large company for lease terms and conditions for the Millennium Expansion Phase III property.

This company is interested in leasing the entire 82 acres between Ernest Crochet Road and Pesson Road.
